### Connecticut Law About Medical Malpractice

In Connecticut's General Statutes 52-584, the medical malpractice statutes of limitations applicable to any type of personal injury lawsuit or claims case in Connecticut, including medical malpractice related causes of action and claims of medical professional negligence, require that patient's file suit by no later than two (2) years after the date of the suspected incident of medical negligence causing injuries has occurred.

### Connecticut Medical Malpractice Laws - Medical Malpractice ...

No Medical Malpractice Damages Cap in Connecticut. Unlike many states, Connecticut has not passed a law that limits (or "caps") damages in medical malpractice cases. So there is no statutory limit on the amount of money that a successful plaintiff can receive, after a jury has found the defendant health care provider(s) liable for medical malpractice.

A statute of repose imposes an absolute deadline to medical malpractice claims, regardless of when the victim discovered them. In Connecticut, the statute of repose is three years. Other Exceptions. Connecticut has other exceptions to the statute of limitations that may apply in a medical malpractice case, depending on the circumstances.

#### Connecticut Supreme Court Nixes Medical Malpractice Suit ...

Connecticut's statute of limitations for personal injury claims, including medical malpractice claims, is two years from the date you sustained the injury or two years from the date when you discovered or should have discovered the injury by exercising reasonable care.

### Connecticut Medical Malpractice Laws and Statutes to Know

Each state has laws governing the length of time you have to file a claim for medical malpractice. This law is known as the statute of limitations. In Connecticut, the statute of limitations for medical malpractice claims is 2 years from the date of the injury or when the injury should have been reasonably discovered.
